### 7. FINANCIAL REPORT – Sue Verrilli, R/TRO and Sue Talmey, CPA, CMA

Sue Talmey, Director of Finance and Administration at Durham Association for Family Resources and Support (DAFRS), the firm that manages the TRO financials, gave an overview of the 2020 financials. A summary of the TRO's unaudited financial statements for the fiscal years are available on the TRO website.

Total revenues for the period were \$278,504 compared to \$356,466 for the 12-month

period ended December 31, 2019. The virtual conference in 2020 accounts for much of the change along with a Federal COVID wage subsidy.

Total expenses were \$237,652 compared to \$353,331 for the 12-month period ended December 31, 2019.

Results show a surplus of \$40,852 for the year, compared to a surplus of \$3,135 for the 12 month period ended December 31, 2019. Our approved budget was for a deficit of \$3,970 so we are pleased to report results came in significantly over budget for the year.

The Statement of Financial Position shows an increase in net assets to \$185,641 from \$144,789 at December 31, 2019, with the surplus for the year creating the increase in net assets.

## **8. REPORT FROM THE CHAIR OF THE BY-LAWS COMMITTEE –** Sue Verrilli, R/TRO

Sue Verrilli reported on the work of the committee explaining the reasons for re-writing the by-laws and walked the membership through the changes, specifically to four major changes:

- Two membership classes Professional and Associate, to allow for greater flexibility as the association grows and evolves. Categories, such as Registered Professional, Students, etc. will be created within the two classes and do not need to be identified in the bylaws.
- Reduce quorum from 15% to 10% In the past, we have had AGMs where we have not been able to meet quorum. Therefore, TRO has not met our legal requirements, nor have members been able to exercise their right to vote.
- Appointment of the Officers Officers are the President, President-elect, Past-President and Secretary. The recommended change allows the Board to plan for succession and, we hope, will encourage members to consider becoming a future president.
- Changing committee structure allows for greater flexibility
